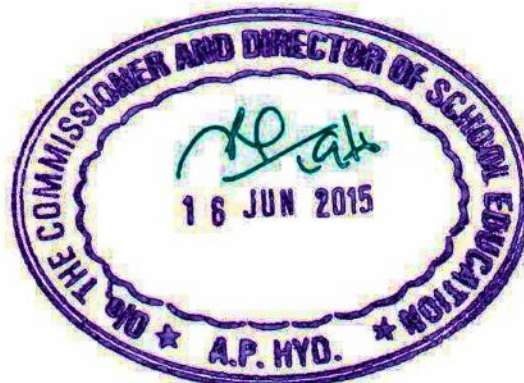
2. The Commissioner & Director of School Education, AP, Hyderabad shall take necessary action accordingly.
